It appearing to the court that the trial date for each of the cases identified as group 15 is April 25, 2005, each having been designed therein on Nov. 2, 2004, MS 2003-00-0022, and

It further appearing that the motion filed by Kelly and Ferraro, on behalf of Plaintiffs they represent, to stay proceedings pending resolution of the video trial issue by the Ninth District Court of Appeals (and now the Ohio Supreme Court), was continued as to group 15, and

It further appearing that the parties may not be prepared to try the remaining cases beginning April 25, 2005, as a consequence of the pendency of ruling on the matter by the Supreme Court (the case having been heard by the court and under advisement), and

It further appearing that parties have not complied with the video filing prerequisites of the extant Case Management Order (i.e. March 20, 2005), and the cases are all in default for compliance,


IN THE INTERESTS OF JUSTICE, it is ordered that the assignment be modified as to group 15 in the following particulars:
