Testimony in these cases has been recorded and preserved on videotape and filed with the court according to the Case Management Orders.

**Civ.R. 41(A) dismissal.** When a case has been dismissed per Civ. R. 41(A), the testimony filed by each party shall be immediately made available to the tendering party, together with all other documentation and exhibits relative thereto filed by such party. These filings will be available at the office of the court and shall be retrieved within 90 days upon signing a receipt upon delivery.

**Case otherwise finally concluded.** As to any case concluded other than pursuant to Civ.R. 41(A), the filed video testimony, together the party's documentation and exhibits, will be held by the court for 90 days following the final appealable judgment, and immediately thereafter made available at the office of the court. They shall be retrieved upon signing a receipt upon delivery.

**Failure to Retrieve – Destruction of tapes, exhibits, documents.** In the event parties fail to retrieve tapes, exhibits, documents so filed within the 90 day periods set forth above, same will be destroyed.

Subject to approval by the Records Commission, the Ohio Historical Society and the Auditor of the State, Bureau of Inspection and Supervision.

This Master File Pleading shall be applicable to the following cases, and the Clerk will so note this master entry in the docket of the below-listed cases by date of Master File and Master File Control number:


